## Travel Time to Count with Volunteer Hours

Your travel time to and from volunteer project sites can count as part of your Virginia Master Naturalist volunteer hours!

Below is the relevant information that Michelle Prysby forwarded when asked about this policy. You can get the entire document on the Documents page of the VMN Web site. Thanks to Elisabeth Wilkins for noting this important point to the Executive Board!

**Travel Time** Starting January 1, 2012, VMN volunteers may count time spent on travel to conduct volunteer service towards the certification requirements and milestone achievements. Volunteers are strongly encouraged to choose service opportunities close to their communities, rather than choosing projects that have very high travel time compared to the actual service time. Volunteers must log travel time as a separate project in the online reporting system so that it is possible for chapters to report the percentage of volunteer time that was spent on travel each year. In addition, Master Naturalists may want to track their mileage on all projects for tax purposes, and the online reporting system provides a field for tracking this information. Only the travel time to and from volunteer service counts towards certification; travel time to and from training (whether the basic training course or advanced training events) does not qualify.

### MEDITERRANEAN QUINOA

2 chicken sausages with cheese and herbs cut into coins  
32 oz. chicken broth  
2 cups quinoa  
3 oz. crumbled feta cheese with herbs  
4-5 oz. sun dried tomatoes in oil

Brown sausage pieces in oil. Set aside.

Cook quinoa in chicken broth. Drain off extra liquid if all is not absorbed.

Add sausage to quinoa. Cool slightly. Add feta cheese. Toss together. Serve warm or at room temperature.

## Balloon Litter Research Project

What do all of these balloons have in common? They were all found as litter in Tidewater over that last few weeks. And, they are all data points in an important citizen science project.

Virginia Clean Waterways, the Virginia Aquarium and Longwood University are teaming up to collect data on balloon litter

found across the Commonwealth. This research project is a two year endeavor to find out more specifics about the types of balloons and balloon attachments that are found in our litter.

In a July 27<sup>th</sup> conversation with Katie Register, director of Virginia Clean Waterways, she said that the purpose of the data collection is to have accurate information to convince balloon manufacturers and retailers to end the promotion of balloon releases. The balloon industry claims that newer balloons are biodegradable. However, the attachments – ribbons, holders, etc. - that are used on balloons offer no such claims. Besides, in the time it takes for a balloon to degrade an animal can become entangled in the ribbons, marine creatures such as sea turtles can ingest the debris and other unfortunate environmental events can occur.

What can you do to help? Pick up the litter, of course! And, report your findings to the project. A data sheet can be printed from the website or you can email your data, making this a litterless project. If you are interested. The website address is:

## PMN and VMN Photography Contests

## Forested Wetlands Mitigation

Thanks to Wes Hudson for explaining the wetlands mitigation process to us at the June advanced training. Not only did he provide us an inside look at how wetlands mitigation, he shared some interesting information about his own research that examines the efficacy of various wetlands reclamation techniques. Wes' project at the Virginia Department of Forestry is an approved project. An announcement from Wes concerning the project:



Dr. Jim Perry's Wetland Ecology Lab at the Virginia Institute of Marine Science seeks volunteers to assist with field work for a 7 year forested wetland investigation. The purpose of this study is to improve the understanding of successful forested wetland restoration in Virginia by investigating the growth and survival of 7 species of native wetland trees planted in three hydrologically distinct mesocosm cells at the Virginia Department of Forestry New Kent Forestry Center. The results from this study will help advance the fields of wetland science and restoration ecology, and we need your help!

We will be measuring the growth and survival of our 3000 trees from 9am to 6pm everyday between August 12 - August 24.

We will be providing transportation from the following locations or you can meet us at the New Kent Forestry Center: Virginia Institute of Marine Science in Gloucester Point, Phi Beta Kappa Hall at William and Mary Main Campus (Jamestown Road,) and the New Kent Forestry Center ([www.dof.virginia.gov/regEast/nkt-index.shtml](http://www.dof.virginia.gov/regEast/nkt-index.shtml))

What to wear:

- Sneakers or boots you don't mind getting dirty
- A hat
- Comfortable clothing, preferably long pants

What to bring:

- A water bottle (we will provide water)
- Sunscreen (we will have some, too)
- Bug spray (optional, the bugs aren't that bad)

Come out and learn valuable skills in identifying tree species, surveying for adaptations, measuring tree growth and collecting data in the field!
